SECTION 2: HAZARDS IDENTIFICATION

Emergency overview: Danger! Corrosive liquid.

Potential short term health effects:

Routes of exposure: Eyes, skin, inhalation, and ingestion.

SECTION 4: FIRST AID MEASURES

Emergency First Aid Procedures:

Eyes: Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after first 5 minutes, then continue rinsing eye. Seek immediate medical attention.

Skin: Remove contaminated clothing and shoes immediately. Wash skin with large amounts of running water, and soap if available, for 15 minutes. Seek immediate medical attention. Wash clothing and decontaminate shoes before reuse.

Ingestion: Rinse mouth with water and then drink plenty of water. Seek immediate medical attention. DO NOT induce vomiting. If vomiting occurs, give fluids again. Have physician determine if patient's condition allows for induction of vomiting or evacuation of the stomach. Do not give anything by mouth to a convulsing or unconscious person.

Inhalation: Move person to fresh air. If not breathing, clear airway and start artificial respiration and call 911 immediate. If victim is having trouble breathing, give supplemental oxygen if available. Seek immediate medical attention.

SECTION 5: FIRE FIGHTING MEASURES

SECTION 6: ACCIDENTAL RELEASE MEASURES

Release or Spill: Avoid walking in spill – floors may become slippery. Dike and contain spill with inert material (sand, earth, etc.) and transfer the liquid and solid separately to containers for recovery or disposal.

SECTION 7: HANDLING AND STORAGE
